

NEIGHBORHOOD COURT: LIST OF OFFENSES

The following offenses are submitted for consideration for participation in the Vacaville Police Neighborhood Court program in partnership with the Solano County District Attorney's Office. This list is not exhaustive and does not include various infractions which may be utilized in this program. The list has been compiled while referencing eligible offense lists for similar programs at Benicia P.D. and in Yolo County.

Any offenses which involve a direct victim would require voluntary participation by both the offender and victim before admittance into the program. Offenses against officers (i.e. PC 148 and PC 148.9) require voluntary participation by victimized officers and offenders.
