### **POLICE ARREST SANTA ROSA MAN ON VARIETY OF CHARGES**

On Thursday, Vacaville police arrested a convicted sex offender from Santa Rosa on charges of molesting a child in Vacaville.

At approximately 9:34 a.m., police received a complaint that an adult male had touched a juvenile in an annoying and sexual manner. The alleged incidents occurred over a two-day period, with at least one of the incidents being seen, which resulted in the police being called.

During their investigation, officers learned the suspect, S-Quen Caine Graham, of Santa Rosa met an adult female who lived in the residence with the victim and his mother on the internet. S-Graham, 34, allegedly lied about himself, giving the female a false name. The female subsequently invited S-Graham to move into the residence that she shared with others. At some point, the suspect was confronted by the juvenile's relatives and family friends about touching the juvenile male victim. Police were contacted, but S-Graham fled out a back door of the home prior to their arrival.

Police did an extensive search of the area but were unable to locate S-Graham. During their investigation, police learned the suspect was a convicted sex offender from Santa Rosa who had failed to register.

Police also learned S-Graham had taken a cab from Vacaville back to Santa Rosa and upon arrival failed to pay the driver. S-Graham fled into a shopping mall and was chased by the driver before Santa Rosa police officers detained him several blocks away. Vacaville police officers then went to Santa Rosa and took custody of S-Graham. He was eventually booked into Solano County jail without incident.

The Vacaville Police Department would like to caution community members that entering into online dating relationships can have inherent dangers. Sex offenders and sexual predators will often use the internet to find unwitting victims. Please be vigilant and don't let anyone have access to your home and children until the proper identification of their guests can be made and their safety can be ensured.
