SEARCH WARRANTS LEAD TO ARREST OF SEVEN ON DRUG, WEAPON CHARGES

Vacaville Police, following a recent investigation, arrested seven people on a variety of drug and weapons charges. Officers with the Vacaville Police Department Narcotics Enforcement Team (NET) conducted an operation on September 5, 2013 in which two respective search warrants were served in the cities of Dixon and Vallejo. NET was assisted by the Vacaville Police Department Crime Suppression Team (CST), California Multi-Jurisdictional Methamphetamine Enforcement Team (CaIMMET / SOLNET), and the Solano County Sheriff's Department.

While serving the search warrants, over a half pound (10+ ounces) of methamphetamine, with a street value of approximately \$10,000, was seized along with over \$7,000 in cash, and three firearms - one being stolen. The suspects from both locations were arrested and booked into jail on numerous drug sales and weapons violations.

S-Irish Donohue (21) of Dixon was arrested and charged with 11378H&S - possession of methamphetamine for sale, 11370.1 H&S - possession of a controlled substance while being armed and 29800(B)PC - violent felon having access to a firearm. S-Donohue is a documented member of the Family Affiliated Irish Mafia (FAIM) gang. S-Dempsey Azich (20) of Vallejo was arrested and charged with 11378H&S - possession of a controlled substance for sale, 1203.2PC - violation of probation and 11370.1H&S - possession of a controlled substance while being armed. S-Mark Rhea (23) of Pinole was arrested and charged with 1203.2PC - violation of probation. S-Kacey Mertz (25) of Dixon was arrested and charged with 11378 H&S - possession of a controlled substance for sale and 11370.1 H&S - possession of a controlled substance while being armed. S-Carlos Miranda, (18) of Antioch was arrested and charged with 11359 H&S - possession of marijuana for sale, 12022(A)(1)PC - armed with a firearm in the commission of a felony. S-Kalyn Decarlo (18) of Vallejo was arrested and charged with 11378 H&S - possession of a controlled substance for sale, 11370.1 H&S - possession of a controlled substance while being armed, 11359 H&S - possession of marijuana for sale, and 496PC - possession of stolen property. S-Jonathan Blakeley (19) of Vallejo was arrested and charged with 11359 H&S - possession of marijuana for sale, 12022(A)(1)PC - armed with a firearm in the commission of a felony, and 1203.2PC - violation of probation.
