VACAVILLE POLICE ARREST THREE IN METH BUST IN ANTIOCH

Vacaville police, with the assistance of officers from other agencies, arrested three Antioch residents Wednesday on a variety of drug and weapons charges.

At around noon Wednesday, members of the Vacaville Police Narcotics Enforcement Team (NET), Vacaville Police Crime Suppression Team (CST), Antioch Police SWAT Team and the West Contra Costa County Narcotics Enforcement Team served three separate search warrants at three homes in Antioch. An investigation into the sales of drugs in Vacaville led officers to the homes in Antioch.

During the services of the warrants, officers discovered over two pounds of methamphetamine, with a street value of between \$50,000 and \$10,000; almost an ounce of cocaine, with a street value of approximately \$1,800; and three pounds of marijuana, packaged for sale. Officers also discovered a loaded handgun at one of the residences.

Arrested in connection with the search warrants were S-Edward Estrella, 30; S-Stormy Teiger, 25; and S-John Lowe, 35. All three are Antioch residents. S-Estrella was arrested without incident during a high-risk traffic stop in Antioch; S-Teiger was arrested at one of the homes during the execution of the search warrant; and S-Lowe was also arrested during a separate traffic stop in Antioch.

S-Estrella was charged with possession of a controlled substance for sale, and possession of a controlled substance while armed. S-Teiger was charged with possession of a controlled substance for sale and aiding a person to commit a felony; and S-Lowe was arrested and booked for possession of a controlled substance for sale; transportation of a controlled substance; and possession of a controlled substance with the intent to sell.
